

ELLISON TRAVEL EXPO 2026 – DRAW PRIZE TERMS & CONDITIONS

1. Eligibility

The prize draw is open to legal residents of Canada (excluding Quebec) who are 18 years of age or older at the time of entry. Employees, contractors, agents, and immediate family members of Ellison Travel & Tours Ltd. (“Sponsor”) and participating travel partners and competitors are not eligible.
